I acknowledge the risks inherent in such hazards and further acknowledge the risks inherent in the operation of 4x4 vehicles and other off-road vehicles on and about the Premises.

I acknowledge and fully understand that I may engage only in off-roading and related activities upon the Premises and that such activities involve risk of serious injury, including permanent disability and death, and severe social and economic losses which may result not only from my own acts, omissions or negligence but from the acts, omissions and negligence of others, and further acknowledge that there may be other risks not known to me or reasonably foreseeable at this time.
